Scope of practice varies by state regulations and by specific facilities. For example, in the state of missouri, a CNA in a nursing home cannot do accuchecks, phlebotomy, insert foley's, hang IV's, Intubate patients, or run EKG's, even if trained and with clinical training validations.

Overall, states reported considering expanding the scope of practice or authorized duties for CNAs to strengthen patient care and safety. States may choose to expand CNA authorized duties so as to equip CNAs with specific training so that the CNA is able to provide a certain level of care do so.
