Although your LLC will keep its federal EIN, you have to amend the name on your tax return or otherwise notify them with a written letter.

Change Your Business Name or Address. The new business name cannot indicate a personnel change. For corporate name changes, you must first register the corporate name change with the Secretary of State's Office. If you only are adding a "DBA" to the existing corporate name, you do not need to make any changes with the Secretary of State's Office.
